Note:

1. **Financial Mediation Bureau (FMB)**

FMB is an independent body set up to help settle disputes between consumers and the financial services providers (including commercial banks, investment banks, Islamic banks, insurance companies - life, general, composite and reinsurance, Takaful operators, development financial institutions, payment system operators and payment instrument issuers). FMB provide fast, convenient and efficient services that are offered free of charge to consumers. FMB is an alternative avenue to the courts for consumers to resolve financial disputes, claims and complaints against the financial services providers.

2. **Agensi Kaunseling dan Pengurusan Kredit (AKPK; the Credit Counseling and Debt Management Agency)**

AKPK is an agency set up by Bank Negara Malaysia to promote prudent financial management for members of the public. Its services are offered free of charge to individuals, which include:

- Financial education, in particular, on the proper use of consumer credit and basic money management skills such as savings and budgeting as well as tips on how to use credit responsibly and debt management.
- Face-to-face counseling and advice on financial management.
- Debt management programme, a personalised debt repayment plan.
