MALAYSIA DEPOSIT INSURANCE CORPORATION  
(TEMPORARY SUSPENSION PERIOD) (AMENDMENT) REGULATIONS 2014

IN exercise of the powers conferred by paragraph 209(1)(a) and subsections 115(3) and 180(1) of the Malaysia Deposit Insurance Corporation Act 2011 [Act 720], the Corporation, with the approval of the Minister, makes the following regulations:

**Citation**

1. These regulations may be cited as the **Malaysia Deposit Insurance Corporation (Temporary Suspension Period) (Amendment) Regulations 2014**.

**Amendment of regulation 2**

2. The Malaysia Deposit Insurance Corporation (Temporary Suspension Period) Regulations 2012 [*P.U. (A) 432/2012*] are amended in regulation 2 by substituting for the words “ten days” wherever appearing the words “two business days”.
