PERINTAH PERBADANAN INSURANS DEPOSIT MALAYSIA (PREMIUM TAHUNAN DAN
PREMIUM PERTAMA BERKENAAN DENGAN ANGGOTA PENERIMA DEPOSIT)
(PINDAAN) 2020

PADA menjalankan kuasa yang diberikan oleh subseksyen 47(1), 48(2) dan 48(3) Akta Perbadanan Insurans Deposit Malaysia 2011 [*Akta 720*], Menteri, atas syor Perbadanan, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Perbadanan Insurans Deposit Malaysia (Premium Tahunan dan Premium Pertama Berkenaan dengan Anggota Penerima Deposit) (Pindaan) 2020**.

(2) Perintah ini hendaklah berkuat kuasa bagi tahun taksiran 2020 dan tahun taksiran 2021.

2. Perintah Perbadanan Insurans Deposit Malaysia (Premium Tahunan dan Premium Pertama Berkenaan dengan Anggota Penerima Deposit) 2011 [*P.U. (A) 28/2011*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam subperenggan 2(1) dengan menggantikan perkataan “kadar premium bagi tahun taksiran yang dinyatakan dalam ruang (2), (3) atau (4) yang” dengan perkataan “kadar premium yang dinyatakan”.

Pindaan Jadual

3. Perintah ibu dipinda dengan menggantikan Jadual Pertama dan Jadual Kedua dengan Jadual yang berikut:

MALAYSIA DEPOSIT INSURANCE CORPORATION (ANNUAL PREMIUM AND FIRST
PREMIUM IN RESPECT OF DEPOSIT-TAKING MEMBERS)
(AMENDMENT) ORDER 2020

IN exercise of the powers conferred by subsections 47(1), 48(2) and 48(3) of the Malaysia Deposit Insurance Corporation Act 2011 [*Act 720*], the Minister, on the recommendation of the Corporation, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Malaysia Deposit Insurance Corporation (Annual Premium and First Premium in Respect of Deposit-Taking Members) (Amendment) Order 2020**.

(2) This Order shall have effect for the assessment year of 2020 and the assessment year of 2021.

Amendment of paragraph 2

2. The Malaysia Deposit Insurance Corporation (Annual Premium and First Premium in Respect of Deposit-Taking Members) Order 2011 [*P.U. (A) 28/2011*], which is referred to as the “principal Order” in this Order, is amended in subparagraph 2(1) by substituting for the words “premium rate for that assessment year specified in column (2), (3) or (4) of” the words “premium rate specified in”.

Amendment of Schedules

3. The principal Order is amended by substituting for the First Schedule and the Second Schedule the following Schedules:
