(PINDAAN) 2020

PADA menjalankan kuasa yang diberikan oleh perenggan 71(1)(b) dan subseksyen 72(2) dan (3) Akta Perbadanan Insurans Deposit Malaysia 2011 [*Akta 720*], Menteri, atas syor Perbadanan, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Perbadanan Insurans Deposit Malaysia (Premium Pertama dan Premium Tahunan berkenaan dengan Anggota Penanggung Insurans) (Pindaan) 2020**.

(2) Perenggan 2 hendaklah berkuat kuasa mulai tahun taksiran 2020.

(3) Perenggan 3 hendaklah berkuat kuasa bagi tahun taksiran 2020 dan tahun taksiran 2021.

Pemotongan perenggan 13

2. Perintah Perbadanan Insurans Deposit Malaysia (Premium Pertama dan Premium Tahunan berkenaan dengan Anggota Penanggung Insurans) 2016 [*P.U. (A) 49/2016*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dengan memotong perenggan 13.

Pindaan Jadual

3. Perintah ibu dipinda dengan menggantikan Jadual Pertama, Jadual Kedua, Jadual Ketiga, Jadual Keempat dan Jadual Kelima dengan Jadual yang berikut:

MALAYSIA DEPOSIT INSURANCE CORPORATION ACT 2011

MALAYSIA DEPOSIT INSURANCE CORPORATION (FIRST PREMIUM AND ANNUAL PREMIUM IN RESPECT OF INSURER MEMBERS) (AMENDMENT) ORDER 2020

IN exercise of the powers conferred by paragraph 71(1)(b) and subsections 72(2) and (3) of the Malaysia Deposit Insurance Corporation Act 2011 [Act 720], the Minister, on the recommendation of the Corporation, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Malaysia Deposit Insurance Corporation (First Premium and Annual Premium in respect of Insurer Members) (Amendment) Order 2020**.

(2) Paragraph 2 shall have effect from the assessment year of 2020.

(3) Paragraph 3 shall have effect for the assessment year of 2020 and the assessment year of 2021.

Deletion of paragraph 13

2. The Malaysia Deposit Insurance Corporation (First Premium and Annual Premium in respect of Insurer Members) Order 2016 [P.U. (A) 49/2016], which is referred to as the “principal Order” in this Order, is amended by deleting paragraph 13.

Amendment of Schedules

3. The principal Order is amended by substituting for the First Schedule, Second Schedule, Third Schedule, Fourth Schedule and Fifth Schedule the following Schedules:
