**AKTA PERBADANAN INSURANS DEPOSIT MALAYSIA 2011**

**PERATURAN-PERATURAN PERBADANAN INSURANS DEPOSIT MALAYSIA  
(SISTEM PREMIUM BERBEZA BERKENAAN DENGAN ANGGOTA  
PENANGGUNG INSURANS) (PINDAAN) 2020**

PADA menjalankan kuasa yang diberikan oleh perenggan 209(1)(a) dan seksyen 77 Akta Perbadanan Insurans Deposit Malaysia 2011 [*Akta 720*], Perbadanan, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Perbadanan Insurans Deposit Malaysia (Sistem Premium Berbeza berkenaan dengan Anggota Penanggung Insurans) (Pindaan) 2020**.

(2) Peraturan-Peraturan ini berkuat kuasa mulai tahun taksiran 2020.

**Pindaan peraturan 4**

2. Peraturan-Peraturan Perbadanan Insurans Deposit Malaysia (Sistem Premium Berbeza berkenaan dengan Anggota Penanggung Insurans) 2012 [*P.U. (A) 496/2012*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam subperaturan 4(1) dengan memasukkan selepas perkataan “tahun taksiran” perkataan “atau pada apa-apa tarikh lain yang ditentukan oleh Perbadanan”.

**Pindaan peraturan 6**

3. Peraturan 6 Peraturan-Peraturan ibu dipinda dengan memasukkan selepas perkataan “suatu tahun taksiran” perkataan “atau pada apa-apa tarikh lain yang ditentukan oleh Perbadanan”.

**Pindaan peraturan 7**

4. Peraturan 7 Peraturan-Peraturan ibu dipinda dengan menggantikan perkataan “pada atau sebelum 15 Mei setiap tahun taksiran” dengan perkataan “dalam tempoh lima belas hari selepas tarikh akhir anggota penanggung insurans itu dikehendaki untuk mengemukakan maklumat kuantitatif di bawah subperaturan 4(1)”.

**Pindaan peraturan 8**

5. Subperaturan 8(1) Peraturan-Peraturan ibu dipinda dengan memasukkan selepas perkataan “tahun taksiran itu” perkataan “atau dalam apa-apa tempoh lain yang ditentukan oleh Perbadanan”.

**Pindaan Jadual**

6. Jadual kepada Peraturan-Peraturan ibu dipinda dalam susunan dalam perenggan 14, berhubung dengan “Taksiran Maklumat” dalam ruang (1), dengan memasukkan selepas perkataan “tahun taksiran” di mana-mana jua terdapat perkataan “atau pada apa-apa tarikh lain yang ditentukan oleh Perbadanan”.

MALAYSIA DEPOSIT INSURANCE CORPORATION ACT 2011

MALAYSIA DEPOSIT INSURANCE CORPORATION (DIFFERENTIAL PREMIUM SYSTEMS  
IN RESPECT OF INSURER MEMBERS) (AMENDMENT) REGULATIONS 2020

In exercise of the powers conferred by paragraph 209(1)(a) and section 77 of the Malaysia Deposit Insurance Corporation Act 2011 [Act 720], the Corporation, with the approval of the Minister, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Malaysia Deposit Insurance Corporation (Differential Premium Systems in respect of Insurer Members) (Amendment) Regulations 2020**.

(2) These Regulations shall have effect from the assessment year of 2020.

**Amendment of regulation 4**

2. The Malaysia Deposit Insurance Corporation (Differential Premium Systems in respect of Insurer Members) Regulations 2012 [P.U. (A) 496/2012], which are referred to as the “principal Regulations” in these Regulations, are amended in subregulation 4(1) by inserting after the words “assessment year” the words “or on any other date specified by the Corporation”.

**Amendment of regulation 6**

3. Regulation 6 of the principal Regulations is amended by inserting after the words “each assessment year” the words “or on any other date specified by the Corporation”.

**Amendment of regulation 7**

4. Regulation 7 of the principal Regulations is amended by substituting for the words “on or before 15 May of each assessment year” the words “within a period of fifteen days from the last date the insurer member is required to submit the quantitative information under subregulation 4(1)”.

**Amendment of regulation 8**

5. Subregulation 8(1) of the principal Regulations is amended by inserting after the words “that assessment year” the words “or within any other period specified by the Corporation”.

**Amendment of the Schedule**

6. The Schedule to the principal Regulations is amended in the table in paragraph 14, in relation to “Assessment of information” in column (1), by inserting after the words “assessment year” wherever appearing the words “or on any other date specified by the Corporation”.
