**MALAYSIA DEPOSIT INSURANCE CORPORATION ACT 2011****MALAYSIA DEPOSIT INSURANCE CORPORATION (FINANCIAL AGREEMENTS

IN exercise of the powers conferred by section 209 of the Malaysia Deposit Insurance Corporation Act 2011 [Act 720], the Corporation, with the approval of the Minister, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Malaysia Deposit Insurance Corporation (Financial Agreements and Transactions) (Revocation) Regulations 2011**.

(2) These Regulations are deemed to have come into operation on 31 December 2010.

**Revocation**

2. The Malaysia Deposit Insurance Corporation (Financial Agreements and Transactions under Paragraph 80(*h*) of the Act) Regulations 2008 [*P.U. (A) 402/2008*] is revoked.
